Call to Order

With a quorum present, Chairman Hahns Hairson called the meeting to order in the Aeris Conference Room at 9:07 AM. There were no guests so no introductions were made.

Review and Adoption of Proposed Meeting Agenda and Introduction of Guests

Chairman Hairston presented the agenda for review and approval. The agenda was amended to move the violations and complaints and June 5 exam results to a new section, after the Industry Correspondence/State of Industry section. A motion to approve the meeting agenda as amended was made by Mike Hall and seconded by Robert Peoples. The motion was approved unanimously with no abstentions.

Review of Meeting Minutes

Chairman Hairston presented the minutes of the April 24, 2019 meeting for review and approval and asked for any modifications. A motion to approve the meeting minutes with no changes was made by Dave Kelly and seconded by Mike Hall. The motion was approved unanimously with no abstentions.

Director's Report

a. Revenues and Expenditures – As of June 30, 2019

b. Elaine Nolen provided statistics on the 2019 renewal process: 434 renewal licenses and 33 inactive licenses were issued as of June 30, 2019. After June 30, 2019, late applicant licenses must be reinstated. Six apprentice licenses will expire before 6/1/2021 and two of those licensees have applied for upcoming exams.

- c. Elaine Nolen provided a legislative update consisting of the July 15, 2019 letter from Department of Legislative Services outlining changes to the Maryland Program Evaluation Act (Sunset Law). Essentially, Sunset reviews will no longer be mandatory and the request for legislation to extend the next termination date will not be made by

Department of Legislative Services, but will need to be made by Board counsel in the year 2029.

- a. The August 7, 2019 exam roster was distributed for review. Elaine Nolen provided a brief description of the qualifications of each applicant and recommended each of the six persons to take an examination. A motion to approve each applicant for examination was made by Mike Hall and seconded by Robert Peoples. Motion was approved unanimously with no abstentions.
- b. Elaine Nolen provided a document entitled Draft Continuing Education Guidance which outlines regulatory requirements and Board policy on the continuing education requirement for license renewals. Modifications were based on Board member comments and discussion. The document will be finalized and posted on the Board website. In addition, a mass mailing will be made so the information is available to all licensees, including those who are not familiar with the Board homepage.
