

#### Status on Local Partner Suggestions

- Help Funding WIP Actions:
  - Chesapeake and Coastal Bays Trust Fund
  - Doubling of BRF
  - Stormwater Fees for 10 most developed jurisdictions
  - Reducing Costs
- Consistent BMP Tracking System:
  - Each sector has unique needs and history.
  - Web-based Stormwater reporting system being developed.
  - Tracking system for SW in place now (11/28/12 Webinar).
  - BMP verification requirements & the need to account for offsets will require tracking systems to evolve.
  - "BMP Historical Cleanup" process, between now and the end of 2014, could influence BMP tracking.



- Financial Support: State and federal grants and loans



# MD Annual BMP Progress Flow

- Currently MDE serves as a conduit for reporting BMPs from all sectors to the Chesapeake Bay Program and urban BMPs to BaySTAT
- CBP Reporting is for the State Fiscal Year July 1 – June 30th
- Annual Progress submissions due to CBP December 1st and requests for data are made in September





# **Reporting Urban SW to EPA**

- Urban BMPs are extracted from annual MS4 BMP Inventories and Notice of Construction Completion forms, 2 very different types of implementation
  - Retrofits



- Non MS4 jurisdictions can also report CBP info using the Interim Collection Form (NOCC forms will still need to go to MDE)
- Reporting maintenance of BMPs to CBP will be required in the future per BMP Verification process

- MDE is developing a similar system to report progress in the Urban Sector





  - <u>BayStat</u> was created by MD in 2007 to assess, coordinate and target Maryland's Chesapeake Bay restoration programs and to provide citizens with a way to track progress
